- These RSUs are scheduled to vest in three substantially equal annual installments beginning on the second quarter after the end of the first year of the vesting period (January 2025 to December 2027). The date of grant was September 1, 2025
- These RSUs are scheduled to vest in three substantially equal annual installments beginning on the second quarter after the end of the first year of the vesting period (January 2026 to December 2028). The date of grant was January 30, 2026.
